- *To promote cultural aspects of the Philippines.*
- *To cooperate with governmental and/or other bodies in any way that will further the welfare and development of the community.*
- *To engage in social and any other activities necessary to attain the Association's objectives free from any political and religious alignment.*

Membership

- *Membership is open to all persons and associations which subscribe to the objectives of the Association. An applicant must be duly proposed by a financial member and seconded by another financial member. Approval of such application is subject to the payment of the set fee and to the acceptance of the executive committee at its monthly meeting, at which stage membership commences.*
- *A right, privilege, or obligation of a person by a virtue of his membership of the Association is not capable of being transferred or transmitted to another person.*
- *All membership fees shall be paid every year on/or before the 1st of July each year. Renewal of notice shall be posted at least one (1) month prior to the date to the contact details provided.*
- *No refund of membership fee will be issued when a member resigns from the Association.*
- *Financial members 18 years old and over have full voting rights and have the right to run for office after being a financial member for 12 months.*
